

# A MESSAGE FROM YOUR MP

Happy Lunar New Year to all the communities celebrating! I send my best wishes for another year of happiness and longevity. I hope you had the chance to celebrate with your families and neighbours.

January was a busy month of outreach with various groups in Cloverdale— Langley City. A special thank you to Dr. Smythe at Trinity Western University for inviting me to speak with her class. I also want to thank the Greater Langley Chamber of Commerce for inviting me to participate in their annual Langley Leadership Panel.

Seniors across Canada have begun receiving a letter to apply for the new Canadian Dental Care Plan (CDCP). Using phased introduction, all uninsured seniors, persons with disabilities, and children under 18 with a family income of less than \$90,000 will have access to the CDCP by June 2024. In 2025, all low-income, uninsured Canadians will have access to the CDCP, helping up to 9 million Canadians. A table with the application schedule is in the bottom right corner of this page. On Page Two, there is a guide explaining how eligible seniors can apply for the CDCP over the phone until April 30, 2024. After May 1, eligible Canadians will be invited to apply online. # Applying for the Canadian Dental Care Plan

You can apply **only if you received a letter** inviting you to apply for the Canadian Dental Care Plan. Letters will be sent in stages from December 2023 to March 2024 to people 70 years of age and over who may be eligible, starting with those over 87 years. Call the automated phone system before April 30, 2024 to complete your application.





#### Private Dental Coverage

You will be asked if you have access to any private dental benefits through:

- a) your employer or a family member's employer benefits;
- **b)** your pension (previous employer) or a family member's pension benefits; or
- c) an insurance or benefits company that you or a family member purchase from.





For yes, press 1. For no, press 9.

### Public Dental Coverage

You will be asked if you have public dental coverage through a social program offered by your province or territory and/or the federal government.

This information is being collected to coordinate the payment of dental claims should you qualify for the Canadian Dental Care Plan.



For yes, press 1. For no, press 9.



You will hear a message that confirms whether you qualify. You will also receive a letter explaining this decision in about 15 business days.

If you qualify, your coverage will begin on the date provided in your welcome package from Sun Life. The package will arrive within 3 months after you apply.
